Injury Type : Close call

A 20-ton rough terrain crane was unloading ventilation components from a truck. The crane's outriggers had been lowered but not extended. As the crane was placing a load weighing 1,100 pounds on the ground, the crane became unstable and tipped over. A nearby worker had to dive out of the way to avoid being struck.

Injury Type : Neck and back injuries
Core Activity : Low-slope roofing

Location : Central Interior ID Number : 2008107970240 Date of Accident : 2008-Jun

A worker fell about 11.5 feet from a flat roof.

Injury Type : Lacerations, soft-tissue injuries

Core Activity: Low-slope roofing

A roofer fell approximately 20 feet from a sloped roof, landing on a 2x10 access plank. No system of fall protection was being used.

Injury Type : Penetration wound to leg

A worker was descending a ladder when he inadvertently shot a 3.5-inch spike into his leg. He was carrying the nail gun with his finger on the trigger. All safety systems were in place and functioning. The nail gun was set to activate on tip contact when the trigger was pulled.

An excavator damaged a 7200-volt conductor while excavating at a construction site. The locate had been done several months earlier and had not shown any underground utilities. Since that time, underground utilities had been installed. A locate is valid for only 10 days.

A worker was on an 8-foot stepladder on the second storey of a wood-frame structure. He was placing a 2x10 joist along the second-storey top plate walls. The joist became unbalanced, slipped off the top plate, and struck the worker, causing him to fall 18.5

Injury Type : Head laceration, arm abrasions

A worker was on a 10-foot stepladder, pulling electrical cable across the T-bar of a false ceiling. He lost his balance and fell about 7 feet. His head was lacerated when it struck a piece of furniture on the way down.

The steel formwork was about $3.3~\text{m} \times 1.6~\text{m}$ and weighed 200 kilograms; it crushed a metal storage crate.
