As an excavator demolished the upper floor of a building, it ruptured a natural gas line. The demolition contractor understood that the natural gas line to the building had been disconnected and blocked, but the line was still active.

A building was being demolished before construction of a new commercial building. An assessment had identified numerous materials and locations containing asbestos, which were required to be safely dealt with before demolition began. The report was ignored, so the demolition exposed workers and the public to the extreme hazards of asbestos.
